

**MODIFICATION # 4
TO
CONTRACT NUMBER 2001-035
BETWEEN THE
COMMONWEALTH OF VIRGINIA
AND
MOTOROLA, INC.**

This MODIFICATION #4 is an agreement between the Commonwealth of Virginia through its Department of State Police, hereinafter referred to as "State" or "Commonwealth," and Motorola, Inc., hereinafter referred to as "Motorola," which modifies Contract Number 2001-035 (the "Contract") between the parties. This Modification # 4 is hereby incorporated into and made an integral part of the Contract effective July 13, 2004. This Modification will be effective as of the last date signed below.

The purpose of this Modification #4 is to modify Article 4.6 of Appendix 1a, STARS Terms and Conditions, regarding passage of title and the milestone payment for Division 1 Microwave Staging. **The replacement page for the Contract Appendix is attached herewith and incorporated herein to reflect Modification # 4 changes.**

Both parties agree to the following:

Appendix 1a – STARS Terms and Conditions

1. Reference Page 25, Article 4.6, subsection (c), Contractor's Title To Materials and Equipment:

The revisions to this Article detail the agreed process for "acceptance of delivery."

Milestone Payment – Microwave Staging Division 1

2. The Division 1 Microwave Staging has been completed. The equipment has been delivered and received by VFP, Inc., Duffield, Virginia, for installation. In accordance with the changes to Article 4.6, subsection (c), Contractor's Title To Materials and Equipment, as described herein, the Commonwealth has agreed to process a 50% payment for this milestone with the balance due upon receipt of all Division 1 microwave equipment at the specific STARS Site locations.

3. Contract Price Adjustments

None.

4. Completion Date Adjustments

None.

The foregoing is the complete and final expression of the parties' agreement to modify Contract 2001-035 and cannot be modified, except by a writing signed by duly authorized representatives of both parties. If there are any inconsistencies between the provisions of this Modification and the provisions of the Contract, the provisions of this Modification will prevail.

ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT REMAIN UNCHANGED AND SHALL REMAIN IN FULL FORCE.

PERSONS SIGNING THIS CONTRACT MODIFICATION ARE AUTHORIZED REPRESENTATIVES OF EACH PARTY TO THIS CONTRACT AND ACKNOWLEDGE THAT EACH PARTY AGREES TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS CONTRACT MODIFICATION.
